- Repairs should always be performed by a qualified electrician.
- Set the power switch to the OFF position before you unplug the unit from the wall, plug the unit into the wall, or plug in devices.
- If external devices are set on top of the cart, remove them before rolling cart around.

SETTING UP YOUR DEVICES UP FRONT

Device slots come set at around 1" wide and are removable to fit larger device width.

 Using a ruler, measure the thickest part of your device. If it is less than 1" thick, skip to next page.



3. Slide Retaining Strip forward & out of the way. Strip can be removed if needed.




5. Adjust spacing as needed.



2. If your device is thicker than 1", locate & remove thumbscrew by turning counter clockwise.



4. Pulling forward, then up, remove divider panel.



6. Slide retaining metal strip into place & replace thumbscrew.



SETTING UP YOUR DEVICES IN BACK

1. Remove basket by pulling forward first, then pull upward.



3. If your device power adapters are "brick" style, feed power cables thru holes.



5. Feed device cables into pass-thru slots to front of cart.



7. Use the supplied Cable Clips to fasten each cable to the divider by pressing down firmly, securing the cable in place.

2. If your device uses "wall wart" style adapters, plug into outlets then skip to step 5.




4. Hook basket(s) back in place & plug power cables into outlets.



Working up front, weave device cables into divider tabs.







AC-PLUS 15 MINUTE CYCLE TIMER

The AC-PLUS is equipped with a 15 Minute Cycle Timer Charging System. Its designed to simplify charging your devices without complicated mode settings or adjustments.



Within 5 seconds of plugging in your cart's power cord, the 15 Minute Cycle Timer on the AC-PLUS will charge half of the devices in your cart at once. It will begin to charge devices which are plugged into power strips on the "A" circuit. Then, after 15 minutes, devices which are on the "B" circuit will charge. This continuous cycle will remain in operation until your cart's External Illuminated LED Power Button is pressed and no longer illuminates.

AC-PLUS-T & AC-45 SMART CHARGING SYSTEM

The AC-PLUS-T and AC-45 are equipped with the INTELLI-SENSE Smart Charging System. Its designed to more efficiently charge your devices while also creating a plug and play environment.




Within 5 seconds of plugging in your cart's power cord, your INTELLI-SENSE Smart Charging System will initiate an test of your devices charging level requirements. Devices which are plugged into power strips that draw the most power will take priority and can take up to 2 hours before switching to the next set of outlets. Once devices are fully charged, the system will remain in a trickle charging state, maintaining your devices battery levels.

If you prefer, a 30 Minute Cycle Mode is available by switching the Mode Selection Switch to the LEFT.T his will start to charge devices which are on the "A" circuit. After 30 minutes, devices which are on the "B" circuit will charge. This continuous cycle will remain in operation until your cart's External Illuminated LED Power Button is pressed and no longer illuminates.

ELECTRICAL TROUBLESHOOTING

IDENTIFYING COMPONENTS



Step 1: Testing the GFCI Module

- 1. With your cart plugged in, open the rear panel door.
- 2. Locate the GFCI Module on the left side bottom of your cart.
- 3. Press down on the Yellow Button (Test).
- 4. Then press the Red Button (Reset).
- 5. Allow 5 seconds for the Charging System to reset.
- 6. If resetting the GFCI Module did not correct the issue, go to Step 2.

Step 2: Testing the Power Cord

- 1. Unplug your cart and remove cords from both ends of the GFCI Module.
- 2. Plug the main Power Cord into the Power Input port located on the left side of the Charging System.
- 3. Plug the cart back into a wall outlet and press the internal Power Button labeled PWR on the Charging System.
- If the system does not power on, verify that your Power Cord is not damaged by plugging in a PC monitor style IEC-320-C13 Power Cord.
- 5. If the system powers on, replace the Power Cord, otherwise go to Step 5.

Step 3: Testing the Power Strips

- 1. Open the rear panel door and locate the 4 vertically mounted Power Strips.
- 2. Verify each switch is in the "RESET" position, not the "OFF" position.
- 3. Using an extension cord, test each Power Strip by unplugging each cord from the charging system and plugging them into the extension cord.
- 4. If one or more Power Strips no longer works, replace as needed.



ELECTRICAL TROUBLESHOOTING

Step 4: Testing the External Power Button


1. With your cart plugged in, open the rear panel door and press the internal Power Button labeled PWR on the charging system.

- 2. If your cart powers on, unplug the Switch Cable from the Charging System.
- 3. Using a small flat head screwdriver, ensure all individual wires are secure.
- 4. Plug the Switch Cable back into the Charging System then press the External Power Button on the side of your cart.
- 5. If the External Power Button does not light up or power on, replace it.



Step 5: Determining your Model Number

- 1. Find the model name and serial number sticker. This sticker may be on the side or back.
- 2. Determine which Charging System is installed by opening the back door / panel.



Step 6: Testing the Charging System




- 1. Remove all plugs from the outlets of your Charging System.
- 2. Power on your system by pressing the internal Power Button.
- 3. Verify the "A" LED illuminates for 15 minutes.
- 4. Then verify the "B" red LED illuminates for 15 minutes.
- 5. If either does not, replace the Charging System.

- 1. Remove all plugs from the outlets of your Charging System.
- 2. Power on your system by pressing the internal Power Button.
- 3. Verify the "1" and "2" LEDs illuminate for about 10 seconds.
- 4. Verify the "3" and "4" LEDs illuminate for about 10 seconds.
- 5. Finally, verify all four LEDs illuminate for about 10 seconds.
- 6. If this sequence does not occur, replace the Charging System.
